

WHITMIRE ART SHARE MY MISSION SWEEPSTAKES - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The Whitmire Art - Share the Mission Sweepstakes ("Sweepstakes") begins on Friday September 29th, 2017 at 8:00 PM EST and ends on Friday December 29th, 2017 at 8:00 PM EST (the "Promotion Period"). The clock used to determine the exact time of the Promotion Period beginning and ending will be the Sponsor's clock.

The sponsor of this Sweepstakes is WhitmireArt.com ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission and processing of Entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. Sponsor may be reached by email at team@whitmireart.com during the Promotion Period.

Copyright and reproduction rights to the Grand Prize painting and its video broadcast are reserved by the artist (Sponsor). Only one prize per person and per household will be awarded. Prizes cannot be transferred, redeemed for cash or substituted by winner. Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant.
